Objective: The objective of the course is to acquire theoretical knowledge in the field of realization and protection of intellectual property in national and international frameworks; familiarizing students with the most important concepts and institutes relevant in this field, the process of exercising the rights of industrial property, procedures, methods and processes of research in this field.			
Outcome: After passing the exam, the student has adopted theoretical knowledge in the field of intellectual property and understands the genesis and development of intellectual property rights; mastered knowledge of basic concepts and institutes in this field, as well as the process of exercising industrial property rights; is qualified to exercise copyright and related rights, protection of intellectual property rights to competent authorities.			
Contents of the course: Theoretical classes: Introduction to the subject; The concept of intellectual property rights; Development of intellectual property; Sources of intellectual property rights; Patent Law; Rights Related to Patent Law; Right to protection of design; The right to trade; The right of the geographical indication of origin; Transfer of industrial property rights; The right to competition in the Republic of Serbia; The right to competition in the European Union. Practical classes: Clarify clarification of some of the topics addressed in lectures, with a special emphasis on the interpretation of key legal concepts and institutes in the field of intellectual property. Analysis of cases from case law, termination of the right to a stamp, protection of copyright works and other. Diskusija selected topics with the active participation of students. Preparation of colloquium and exams. Evaluation of realized teaching and analysis of its results.
